Capacité maximale de charge autorisée 75 kg. Ne pas dépasser le poids total autorisé en charge (PTAC) du véhicule. Les consignes du constructeur du véhicule concernant la charge de toit maximale doivent être respectées. Détermination de la charge de toit effective : poids des barres de toit + poids du coffre de toit + poids de la charge transportée = charge de toit effective

Il est indispensable que la charge soit fixée d'une manière sûre et adéquate.

Le serrage des dispositifs de fixation et des pièces de sécurité, des barres porte-charges de toit, ainsi que des accessoires ajoutés doivent être vérifiés après chaque changement et régulièrement pendant le trajet. Resserrer si nécessaire.

Dans tous les cas respecter la réglementation en vigueur.

La charge doit être uniformément répartie sur les barres et le centre de gravité le plus bas possible

Veillez à placer les charges lourdes et étroites près des pattes de fixation des barres.

Il est nécessaire que les chargements débordants des barres remplissent les prescriptions de la réglementation en vigueur et soient convenablement arimés.

Toute charge transportée sur le pavillon d'un véhicule affecte d'une manière sensible son comportement, en particulier la sensibilité au vent latéral et le comportement en virage et au freinage. Con el fin de reducir el consumo de combustible, se aconseja quitar las barras portacargas del techo después de su utilización.

Fissare sempre il carico in modo adeguato e sicuro

La chiusura dei dispositivi di fissaggio e dei pezzi di sicurezza, delle barre portatutto, e di tutti gli accessori utilizzati, devono essere verificati dopo ogni utilizzo e regolarmente durante il tragitto, se necessario riprendere la coppia di chiusura.

In ogni situazione, rispettare sempre le norme in vigore.

Il carico deve sempre essere uniformemente distribuito sulle barre, il centro di gravità deve essere il più basso possibile.

Cercare di posizionare i carichi più pesanti, in corrispondenza dei fissaggi delle barre portatutto.

Tutti i carichi debordanti dalle barre portatutto soddisfino i requisiti della regolamentazione in vigore, fissare i carichi debordanti in modo

corretto (se possibile sfruttare i ganci di traino del veicolo posti in corrispondenza dei paraurti).

Tutti i carichi trasportati sul tetto del veicolo, incidono sensibilmente sul comportamento del veicolo, in particolare la sensibilità al vento laterale ed il comportamento in curva e in frenata. Consigliamo sempre di condurre il veicolo con molta prudenza (ridurre la velocità, tenendo conto dell'aumento degli spazi di frenata).

Al fine di ridurre il consumo di carburante, consigliamo di smontare le barre porta carico dal tetto dopo ogni utilizzo.

Attenzione: Utilizzare sempre degli accessori affidabili e ben conservati, verificando il corretto stato prima e dopo ogni utilizzo.

Le barre da carico, possono essere utilizzate esclusivamente per gli utilizzi indicati dal costruttore.

Conservare e leggere sempre le istruzioni di montaggio e di utilizzo.

Gli accessori da tetto possono causare rumore o fischi durante il loro utilizzo.

Non utilizzare mai questo prodotto, abbinato a tende da tetto di ogni tipo.

Keep this manual permanently. Maximum load weight is 75kg.

The total permissible laden weight of the given motor vehicle may not be exceeded. The instructions of the motor vehicle manufacturer in respect of the maximum roof weight must be observed.

Calculation of available roof load: Weight of roof rack + weight of roofbox + weight of payload = available roof load

It is essential to ensure the load is safely and adequately fixed.

The tightness of the fixation devices and security parts, and the roof rack load bars, as well as any additional accessories, must be checked once loaded and regularly during the journey. Retighten if necessary.

Adhere to the manufacturer's instructions regarding the maximum authorised load on the vehicle.

Adhere to the manufacturer's instructions regarding assembly and maximum authorised load of roof racks.

In all cases, respect current regulations.

The load must be evenly distributed over the roof rack and the centre of gravity should be as low as possible.

Be careful to place heavy and narrow loads near to the rack's fixing points.

Loads which overhang the roof rack must conform to current regulations and be properly secured.

Any load carried on the roof of a vehicle significantly affects its behaviour, in particular its tolerance to side winds, its behaviour in bends and on braking. It is recommended to drive more carefully (reduce speed, be aware of increased braking distances).

In order to reduce fuel consumption you are recommended to remove the roof rack after use.

Attention: Secure the load correctly and safely.

Use reliable and well-maintained material and check it is in good order before and after each use.

The roof rack may only be used for the functions specified by the constructor.

It is important to keep the assembly and usage instructions.

Roof accessories can cause noise or turbulence during use.

Do not fix the accessory to other brand's fixing systems.

Never exceed the speed limit indicated on the first page of the manual.
